RESOLUTION NO. 21-2018 OF THE TOWN BOARD OF THE TOWN OF ELBA AUTHORIZING THE TOWN SUPERVISOR TO EXECUTE AN UNDERTAKING FOR THE BENEFIT OF THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION

Councilwoman Marshall offered the following:

WHEREAS, the Town of Elba from time to time receives permits from the New York State Department of Transportation (hereinafter referred to as the "NYSDOT") and otherwise conducts activities and operations upon highways and/or within right-of-way controlled by the State of New York for such purposes as the obstruction, installation, construction, maintenance and/or operation of facilities; and

WHEREAS, the Town's access and operation upon state rights-of-way is conditioned upon compliance with the Highway Law Sections 52, 103, 203 and/or 234, including the condition that the Town assume all responsibility for (a) the temporary control of all modes of traffic (including motorized and non-motorized travel(affected the Town's operations, (b) complete restoration of state facilities to their condition prior to permitted use or activity, and (c) all claims, damages, losses and expenses, and

WHEREAS, in addition to the Town's evidence of insurance for each instance in which the Town conducts activities upon state highways and rights-of-way, the Town is required to provide an undertaking to NYSDOT covering situations such as: Permit Applications; Applicable Rules, Regulations & Conditions Control; Site Restoration; Payment & Release of Liens; and Indemnity; and

WHEREAS, the Town Board of the Town of Elba believes it is in the best interest of the Town of Elba to authorize the Supervisor to execute the undertaking annexed hereto as Exhibit "A",

NOW, THEREFORE, IT IS HEREBY

RESOLVED, that the Town Board of the Town of Elba hereby authorizes the Town Supervisor, or his designees, to execute the undertaking annexed hereto as Exhibit "A" and deliver same to the New York State Department of Transportation.

NOTICE OF PUBLIC HEARING TOWN OF ELBA

PLEASE TAKE NOTICE that a Public Hearing will be held by the Town Board of the Town of Elba, at the Elba Town Hall, 7 Maple Avenue, Elba, New York on July 10, 2018 at 2:00pm on the enactment of a Local Law known as A LOCAL LAW ESTABLISHING THE WATER CODE OF THE TOWN OF ELBA, GENESEE COUNTY, NEW YORK. Such Local Law provides for water use rates, payment for water usage, provides for and ensures proper and safe water usage, and establishes rights and obligations of water users in the Town of Elba and to any out of district users. Such Local Law further establishes a Water Service Head Loss Chart, a Fee Schedule and Water Service details. A copy of the entire text of the Local Law may be reviewed at the office of the Elba Town Clerk at any time during usual business hours. A copy of the entire Local Law may be obtained from the Town Clerk. All local laws or regulations, or parts or portions thereof that conflict or are contrary to any provision of this local law will be repealed.

At such public hearing, all persons, either for or against the same shall be heard.

Building and Grounds

Superintendent of Highway Yungfleisch reported that he is still waiting for a quote on the repair needed on the truck bay.

The Planning Board believes that while it is not necessary to have a conversation with those wanting a land separation it helps in walking them through the process. The application will be added to the website.

DEPARTMENT REPORTS

Highway

Superintendent of Highways Yungfleisch reported that he and his crew have successfully paved Graham and Snyder Roads. They were also able to pave part of Strouts Road with black top that the County had left over. They are waiting on their turn with the shoulder machine. Mr. Yungfleisch has been meeting with Randsco to start planning for Water District 2, Phase 1 which is scheduled to begin June 18th.

Assessor

ZEO/CEO

Mr. Mikolajczyk's report was emailed and is also available in the Town Clerk's office.

Town Clerk

Town Clerk Werth reported that she took in \$780.49 and remitted \$709.49 to the Supervisor for local share and \$71.00 to NYS Ag. & Markets. A total of 2 new dogs were licensed, 22 licenses renewed and there was one dog seized.

Received a phone call from NYS Vital Statistics Division; must go live with EDR by June 28th of this year. Training was completed Monday, June 11th.

Town Clerk Werth gave the board for their review, the three month NYS Retirement calendars that log her daily work activities. All members signed the calendars and they will be sent to Ashley at Baldwin Business Services. Ashley will send to the State to report for retirement service credit.

Supervisor

Supervisor Hynes reported that the first Pre Construction meeting for Water District 2, Phase 1 went well on May 30th. Construction is scheduled to begin the week of June 18th. Randsco expects to have three crews working. Adam, Project Manager has been in town this week and has worked with Superintendent of Highways Yungfleisch to set up staging areas for pipes and hydrants. Mr. Yungfleisch has mowed the grass in all the staging areas as well.

Supervisor Hynes, Councilwoman Marshall and Town Clerk Werth met with Dawn from Rural Development on May 30th as well to go over the compliance review. The Town Hall needs quite a bit of work to make it accessible to individuals with disabilities or offer reasonable accommodations. This will need to be an ongoing conversation for the Town Board. Dawn also shared that all letterhead and printed material must contain a Telecommunication Device for the Deaf (TDD) number and a nondiscrimination statement. New posters stating "...And Justice for All" and "Equal Opportunity" are required to be displayed in the Town Hall as well. Rural Development will complete a compliance review every three years for the life of the loan.

The Skye property has been completed. Dave Schubel will finalize all the bills that will need to be paid by the July meeting.

The NYS Comptroller Auditor continues to be here. We have addressed many issues that he has brought to our attention. We are not sure how much longer he will be with us.

We will need to change credit cards soon. The cards we have now are managed by an outside company, not M&T. There is concern from M&T as they are no longer able to access these accounts. M&T will offer new cards and will help the switch

We have a meeting scheduled with Laurie Finn from the Commercial Office of M&T on June 20th. They will offer technical training on the check scanner as well as web banking for the Town accounts. They are offering these services at no cost because of their upcoming move out of Elba.

OLD BUSINESS

A lengthy discussion took place on our current website/host/domain and all the problems the Town continues to have with email and web service. A **MOTION** was offered by Councilman Coughlin to move all Information Technology services to Millennium Computers, second by Supervisor Hynes.
