In the Matter of the Proposed Increase in the Maximum Amount to be Expended on Water District No. 2 from \$17,769,000.00 to \$18,800,000.00, pursuant to Section 209-h of the Town Law

ORDER CALLING PUBLIC HEARING

TO BE HELD ON AUGUST 8, 2019 AT 7:00 PM (PREVAILING TIME)

WHEREAS, the Town Board of the Town of Elba formed Elba Water District No. 2 in accordance Town Law Article 12-A, a Final Order Establishing District having been duly adopted July 19, 2017, a certified copy of which having been recorded in the Genesee County Clerk's Office on July 21, 2017, and

WHEREAS, the Final Order provided that Water District No. 2 was to be constructed at a maximum cost not to exceed \$17,769,000.00, and

WHEREAS, the Town Board of the Town of Elba wishes to increase the maximum amount to be expanded for construction of Water District No. 2 from \$17,769,000.00 to \$18,800,000.00 due to significant upgrades to the overall Genesee County Water System, and

WHEREAS, the upgrades include the County of Genesee making a financial contribution to the Town of Elba to upsize the Town of Elba Water storage tank and to upsize certain of the Town's water mains from 8 inches to 12 inches, and

WHEREAS, to simplify the construction coordination and reduce costs, the County's improvements will be completed as part of the Town of Elba Water District No. 2 project, and

WHEREAS, a revised map, plan and report has been prepared by Clark Patterson Lee dated July 2019, which engineers are duly licensed in the State of New York, and which revised map, plan and report is on file in the office of the Elba Town Clerk for public inspection, and

WHEREAS, the maximum amount to be expended as stated in the revised map, plan and report is increased from \$17,769,000.00 to \$18,800,000.00, with the entire additional amount of \$995,000.00 to be expended for County upgrades is to be paid by Genesee County as more particularly set forth in an Intermunicipal Agreement between Genesee County and the Town of Elba, a copy of which is enclosed as an appendix to the revised map, plan and report, and

WHEREAS, the Village of Elba will make an additional financial contribution of \$36,000.00 relative to the Village tank demolition, and

WHEREAS, the original map, plan and report estimated the cost of the district to a typical one or two

family home in the amount of \$1,035.00, and the revised map, plan and report now estimates the cost of the

district to a typical family home in the amount of \$1,044.00, the \$9.00 increase as a result of the estimated

yearly water cost with the estimated debt service of \$738.00 remaining the same in the map, plan and report,

and the revised map, plan and report, and

WHEREAS, the other one-time costs remain the same in the revised map, plan and report, and

WHEREAS, the boundaries of Water District No. 2 will remain the same and the total number of Units

will remain the same, and

WHEREAS, the Town of Elba Town Board proposes to increase the maximum amount to be expended

and to conduct a hearing with respect to same and to hear all persons interested in the subject thereof and

concerning the same in accordance with the provisions of section 209-h of the Town Law, and

WHEREAS, the New York State Comptroller's approval is required for such increase.

NOW THEREFORE BE IT:

ORDERED, that the Town Board of the Town of Elba meet and hold a public hearing at the Elba Town

Hall, 7 Maple Avenue, Elba, New York on the 8th day of August 2019 at 7:00p.m. (Prevailing Time) to consider

an increase in the maximum amount to be expended for Elba Water District No. 2 from \$17,769,000.00 to

\$18,800,000.00 and take such other and further action as may be required and authorized by law; and be it

FURTHER ORDERED, that the Town Clerk publish at least once in the "The Daily News", a

newspaper designated as the official newspaper of the Town for such publications, and post on the sign board

of the Town maintained pursuant to section 209-d of the Town Law, a copy of this Order, certified by said

Town Clerk, the first publication and said posting to be not less than ten (10) nor more than twenty (20) days

before the day designated herein for said public hearing; and it is

Schultz, Lot #473, 3 and 4

Remove existing stone and foundation. Replace with new foundation. \$275.00

All prices contingent on head stones not being connected to the foundations.

Councilman Chamberlain stated there have only been these two complaints, but Mr. Davis states there are several other foundations sinking in the cemetery. Mr. Davis was asked to make a list. Councilman Chamberlain will speak with Mr. Davis to ensure he completes the work on his own, the foundations need to be dug at least three feet and someone will need to inspect before it is poured.

Highway

Superintendent of Highways Yungfleisch reported:

- We are receiving \$14k from the State for the extreme winter.

- They will stone/oil and blacktop a few more roads this summer.

Assessor

The State of New York has issued an equalization rate for the 2019 Final Elba Assessment Roll of 100%. The changes were enough to get 100%. Two sales in June were more than 15% above the 2019 assessments so we will wait till September or October to see what the State's projection will be on how much values may need to rise in 2020 to stay at 100%.
