WHEREAS, the Town Board of the Town of Elba, New York desires to consider adopting legislation to override the limit on the amount of real property taxes that may be levied by the Town of Elba pursuant to General Municipal Law § 3-c, and to allow the Town of Elba to adopt a town budget for fiscal year 2020 that requires a real property tax levy in excess of the tax levy limit, also known as Town of Elba Local Law No. 1 of 2019.

NOW, THEREFORE, BE IT RESOLVED by the Town Board for the Town of Elba, New York that proposed Local Law No. 1 of 2019 entitled "A Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c", which proposed Local Law is now in its final form as appears by a copy thereof hereto attached, be and the same hereby is introduced for adoption; and

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Elba pursuant to General Municipal Law §3-c, and to allow the Town of Elba to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Elba, County of Genesee, is hereby authorized to adopt a budget for the fiscal year 2020 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in it separation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

Zoning Board

Councilman Chamberlain reported:

- There were a total of four Public Hearings at the October meeting. They included four barns with either side, rear or front variances on Snyder Road, Ridge Road, Weatherwax Road and Chapel Street. All were approved at their meeting with the exception of the Chapel Street property. The Committee met earlier today at the property and used a string line to determine the proper dimensions. The builder moved the stakes to adapt the three foot discrepancy. All approved.
- Ms. Barbie Starowitz attended the ZBA meeting and continues to have concerns regarding an alleged multi family dwelling at 7351 Bank Street Road. She stated that there were recently three 911 calls at this property that she attended with the Fire Department. The homeowner had applied for a variance and was sent to the Genesee County Planning Board. He was told he would need to increase the septic, parking, etc. ZEO/CEO Mikolajczyk has followed through on the complaint by speaking to the resident. The resident states it is not a multi family dwelling. Supervisor Hynes will discuss with Mr. Mikolajczyk, our Town Attorney, Dave Schubel and Planning Board Chair Chuck Hoover to ensure that the Town Board is performing their due diligence on this complaint.

Planning Board

Councilman Coughlin reported:

- Mr. Kriwox brought in the mylar for their property on Barrville Road. Therefore they approved the land separation request.
- Planning Board Member, Brad Mudrzynski presented a draft copy of the solar project they have been working on. Once they have reviewed it will be passed onto the ZBA and Town Board.

<u>Highway</u>

Superintendent of Highways Yungfleisch reported:

- The pick up truck is in the shop, transmission issues.
- One ton truck is also in the shop.

- The salt we have in the shed needs to last until January 1st.
- The MEO's will install the snow fence once it dries up.
- The new truck will be here week.

Mr. Mikolajczyk's report was emailed and is also available in the Town Clerk's office.

Town Clerk

Town Clerk Werth reported that she took in \$2,072.46 and remitted \$1,998.96 to the Supervisor for local share, \$51.00 to NYS Ag. & Markets for spay/neuter program and \$22.50 to NYSDOH.

Councilwoman Marshall recommended we look into purchasing a copier for the Town versus having a lease with Toshiba. Town Clerk Werth will look into this.

<u>Supervisor</u>

- The November meeting will take place on November 7th, starting at 6:45 p.m. with three Public Hearings.
- Rural Development gave the go ahead to proceed with Phase 5. Randsco will start on Lockport Road within the next week.
- Judge Adam Howard submitted his letter of resignation effective November 6, 2019. The Republican Committee is meeting on October 21st to interview possible candidates to fill the position. This person will need to be appointed at the November meeting in order to attend the week long training in Albany starting December 2nd. Judge King has asked for additional compensation for the extra time he will put in covering Judge Howard.
 - Councilwoman Marshall asked in the numbers were still down in court cases? She also asked if there was a possibility of consolidating with Oakfield court. Supervisor Hynes will inquire.
- Lee Walters, CPA finished the independent audit for Water District 2 and sent it on to the Federal Government. Copies were provided to Board members. Mr. Walters will provide this audit annually as long as the project is taking place.

Councilpersons

- Councilwoman Zambito asked if we heard about the signage at the bank. Supervisor Hynes stated she spoke with Town Attorney, Dave Schubel and there is no conflict of interest for the Town to have M&T on the same sign.
- Councilwoman Marshall suggested that a notice go out from Mr. Flansburg, Assessor with the changes for the Agricultural Assessment requirements for March 1, 2020.
- Councilwoman Marshall had a chance to assess a few policies. She stated we are not in bad shape as we have all the policies that are required. The Town Board reviewed the following policies:
 - Cell Phone Policy OK
 - Town Email Town Clerk Werth to speak with Millennium for a price on adding Town Board members to Town email.
 - Procurement Policy Superintendent of Highways Yungfleisch to review.
 - Code of Ethics Adopt Comptroller's policy.

It was also discussed that the Comptroller offers information for Town Officials. The Town Board should review these policies each year at the annual meeting.

• Councilman Chamberlain stated he researched the signs in Barre regarding Windmills "lowering your taxes". This is very misleading to taxpayers. Barre and Byron each have solar projects coming through their town and they do not have solar plans. This should encourage us to put a plan in place soon. We need to consider this for long range.
