## **PUBLIC PARTICIPATION**

Mr. Harrison Luna who represents Hecate Energy joined the meeting via teleconference. Mr. Luna provided a quick overview of the project:

- 500-megawatt photovoltaic solar facility that is planned for approximately 3,000 acres in the Towns of Elba and East Oakfield
- Section 94-c of the Executive Law, is a major renewable energy development program. This is different and quicker than the Article 10 process, this allows the section to consolidate the environmental review and permits of major renewable energy facilities
- They are through the first study now and entering class year towards the end of 2020
- Currently surveying is taking place, title work, geo technical work, etc.
- There are host and community benefits that are required with the county, town and school, tax benefits, American solar grazing to keep land under panels in an agricultural nature, etc.
- Life of panels is 20-30 year for these Tier 1 panels by Bluebird
- Contracts typically last 15 years
- Hecate Energy has smaller projects in Greene and Columbia County but none of this caliber
- Weekly zoom meeting regarding the project, link can be found on the project website www.cidersolarfarm.com
- They are looking to plan an open house sometime in October.

## Highway

#### ZEO/CEO

Mr. Mikolajczyk's report was emailed to members of the Town Board and is also available in the Town Clerk's office.

## **Town Clerk**

Town Clerk Werth reported that she took in \$865.00 and remitted \$819.00 to the Supervisor for local share, \$46.00 to NYS Ag. & Markets for spay/neuter program.

We received the Docuware scanner and have started training on the system. We hope to start working with the scanner within the next few weeks.

## **Supervisor**

Supervisor Hynes reported the following:

- The Town of Barre Supervisor, Sean Pogue stopped by to introduce himself. He discussed water for residents in Barre that live on White City Road and Oak Orchard Road as Barre will not be going that far South with their project. Supervisor Hynes recommended that he find out which of the residents are interested, they would then need to form a water district as well as determine costs for this.
- WD2, Phase 4 They watered up the main coming into the tank. It was chlorinated and ready to fill. They were unable to move forward with filling the tank because the grout that is at the base of the cone crumbled away. Caldwell came to replace it and it still failed to meet the engineering requirements. Therefore, Nichols Long and Moore have agreed to replace the group one more time. This process should be approved by the middle of next week. Once completed they will start filling the tank. Once the new tank gets to a certain level they will shut off the main to the Village tank.
- Supervisor Hynes distributed the budget report. She has scheduled a meeting with Justin from Baldwin for September 28<sup>th</sup> at 4:00 p.m. This will be placed in the paper as a Special Town Board meeting.

• Supervisor Hynes will email the Board Members the information from the CPL architect regarding the new Town Hall. There is a asbestos investigation scheduled. Looking to add a commercial dehumidifier for the basement to help with moisture. The shrubs will need to be removed for the gas meter. Mr. Yungfleisch will have the MEO's remove.

## **Councilpersons**

Councilwoman Marshall mentioned the Fire District was have a public vote on September 15<sup>th</sup> for the purpose of bond to purchase a brush truck. Discussion ensued; Supervisor Hynes will recommend to the Fire District that they post the vote in several locations throughout the Town/Village.

Councilman Chamberlain stated he will finally have internet in a few weeks from Spectrum.
