## <u>Exhibit A</u>

#### 2.8 Adjustments of Equivalent Dwelling Unit (EDU) for Agricultural & Non-Residential Facilities

The EDU charge for agricultural and non-residential facilities shall be adjusted annually based on the average daily usage using the previous 12 months of actual metered water usage data. If 12 months of actual metered water usage data is not available, the average daily usage shall be calculated using all available metered data.

The gross EDU charge shall be calculated by dividing the average daily usage by 300 GPD, which is the typical daily usage for a residential connection. The gross EDU total then is multiplied by the appropriate multiplier (see table below) and rounded down to the nearest 1.0 EDU to determine the new EDU value.

Average Daily Usage	% of Gross EDU
Agricultural & Non-Residential Usage (0 - 1,000 GPD)	100%

#### **EDU Multiplier Table**

Agricultural & Non-Residential Usage	40%

## Sample EDU Calculation #1 as follows:

Quarter 1 water usage = 678,000 gallons Quarter 2 water usage = 683,000 gallons Quarter 3 water usage = 777,000 gallons Quarter 4 water usage = 593,000 gallons

Total Annual Water Usage = 2,731,000 gallons

Average Daily Water Usage = 2,731,000 gallons ÷ 365 days = 7,482 gallons/day (GPD)

EDU multiplier = 40% (based on table)

7,482 GPD ÷ 300 GPD = 24.94 EDU (gross)

24.94 EDU (gross) x 40% = 9.976 EDU = 9 EDU (Rounded down)

## Sample EDU Calculation #2 as follows:

Quarter 1 water usage = no data (not connected to system) Quarter 2 water usage = 84,000 gallons Quarter 3 water usage = 82,000 gallons Quarter 4 water usage = 81,000 gallons

Total Water Usage = 247,000 gallons (3 quarters)

Average Daily Water Usage = 247,000 gallons ÷ 273 days = 905 gallons/day (GPD)

EDU multiplier = 100% (based on table)

905 GPD ÷ 300 GPD = 3.02 EDU (gross)

3.02 EDU (gross) x 100% = 3.02 EDU = **3 EDU (Rounded down)**

## **COMMITTEE REPORTS**

#### **Building and Grounds**

Mr. Yungfleisch reported:

• The office move has been completed. Getting things in order at the old office. They took out the two overhead doors and replaced with windows. Still waiting on the main overhead door to arrive. The record room is now gone and is part of the garage, all records were moved into the former conference room. The old Town Clerk's office will house signs, the former Supervisor's office will be a breakroom for the MEO's and the Assessor's office will become the Highway Superintendents office. Having the garage out front will offer an area for the trucks to be worked on and the back will be where the trucks and equipment is stored. A total of \$31k has been spent so far. Still need to insulate and complete electric work.

## <u>Zoning Board</u>

Mr. Chamberlain reported they have a good crew. The Committee recommended John Given for another five year term. They are working on completing their training hours.

## <u> Planning Board</u>

Mr. Coughlin reported the following:

- There was a Public Hearing for the Piscitelli's for the apartment building at 15 North Main Street. No one from the public attended the hearing, the Genesee County Planning Board has requested the Piscitelli's either merge the properties for parking purposes or get an easement. They will move forward in getting an easement.
- BW Solar has slowed has not filed their application yet, funding has slowed down from NYSERDA
- NYS Ag and Markets have changed the law that they must review anything over 30 acres to insure it is not prime agricultural land. Forefront project on Norton Road was not required to follow the new laws. However, they reduced some of the footprint to be accommodating to NYSERDA.
- After four PILOT meetings an amount has not been agreed upon. Hecate still has not fully completed their application to ORES, they continue to identify deficiencies.
- The Committee will continue to work on training.

#### Town of Elba

• Dwight Kanyuck, Attorney will write the wind energy law for the Town.

## GAM

Councilman Augello reported the surveys will be going out this week for the fire study, MRI hopes to have the report completed by May 2022. There was discussion about the survey the State is sending out regarding statewide broadband. #### <u>Supervisor</u>

Supervisor Hynes reported the following:

- Mr. Yungfleisch and Supervisor Hynes met with Lawley to review the insurance policy. Everything is in order, there is a \$17.00 increase over last year. They did recommend that we put together a Local Law, "Notice of Highway Defects." They will consider this proactive once the law is enacted and it will help with our annual renewal next year.
- Supervisor Hynes spoke with Dwight Kanyuck, Attorney regarding the Town Wind Law. He said it would take approximately 10 hours for him to complete and would charge us \$2,600.00. He will work on this after the first of the new year.
- The year end meeting will take place December 29<sup>th</sup> at 3:00 p.m. The organizational meeting and the first meeting of 2021 will be held.
- The phone system has not been ported over yet from 7 Maple Avenue. Supervisor Hynes has been working on this for three weeks and learned today it was not set up properly. She finally found help with someone at Enterprise of WNY, this is apparently the company that helps municipalities. Hoping to have this issue solved over the next week.

## **Councilpersons**

Councilwoman Marshall reminded everyone that the Fire District will have their elections December 14<sup>th</sup> at

the Fire Hall in the Village from 5-7:00 p.m. Mr. Kevin Dart is up for re-election.
