**WHEREAS**, this Resolution 62-2021 is meant to ensure due and proper notice being timely published; and

**WHEREAS**, notice of this public hearing was duly advertised in the Batavia Daily News, the official newspaper of the Town, on or about December 21, 2021; and

**WHEREAS**, said public hearing was duly held on December 29, 2021 at 2:55 p.m. at the Town Hall and all parties in attendance were permitted an opportunity to speak on behalf of, or in opposition to, said proposed local law, or any part thereof; and

**WHEREAS**, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said local law;

**NOW, ON MOTION OF** Councilman Coughlin, which has been duly seconded by Councilman Augello, be it therefore
