- NY State has issued the permit for the Cider Solar Project. Hecate is pushing GCEDC to finalize paperwork. There are several sticking points that are being reviewed. Waiting for Steve Hyde to return and address the EDC issues.
- Waiting for word on the Comprehensive Plan.
- Supervisor Hynes and Fire Chief Heale attended a meeting concerning the MRI report for the Fire Task Force. Eric Weis, Chairman and Time Yaeger, Genesee County Emergency Management Coordinator shared information with the media. They also discussed the 95 points that the MRI group suggested working on while moving forward. The Task Force will continue to meet monthly and will send a letter to each municipality and Fire Department. They would like them to share their top 10-15 items that they would like to see addressed. They will also be seeking names of individuals to add to subgroups that will be formed. The process will take several years to make the necessary changes to assure the resident sin our communities that the fire service will be here to protect.
