RESOLUTION NO. 6-2024

CLOSING OF ROADS FOR ARC GLOW FRIENDS & FAMILY 5K

WHEREAS, the Arc GLOW Friends & Family 5K, has scheduled a 5K race to take place on Saturday, September 21, 2024, 8:50 A.M.-10:50 A.M. in Elba, New York.

WHEREAS, the proposed race will start on Barrville Road, Elba, New York and includes portions of Bridge Road and Luddington Road and ends at the Genesee ARC facility on Barrville Road,

WHEREAS, the Town Board of the Town of Elba has determined that it is necessary to close portions of Barrville Road, Bridge Road and Luddington Road in the Town of Elba, New York as described herein in order to adequately protect the health, safety and welfare of the participants in the race and spectators along said route, and

BE IT FURTHER RESOLVED AND ORDERED that the Town Clerk of the Town of Elba, New York shall post a copy of this Resolution and Order on the signboard maintained at her office on or before August 1, 2024, and shall remain posted until Monday, September 23, 2024.

RESOLUTION NO. 6-2024

SNYDER BROTHER’S CEMETERY SERVICE INCREASE

WHEREAS, the Elba Town Board received notice from Snyder Brother’s Cemetery Service that they will increase prices for grave openings and closing. The charge will now be \$475.00 for their service,

WHEREAS, Snyder Brother’s Cemetery Service will also charge an additional \$300.00 for Sundays and Holidays, \$250.00 for Saturdays and an overtime charge of \$150.00 per hour for funerals that arrive at the cemetery after 3:00 p.m.

WHEREAS, a regular burial charge will now be (currently - \$950.00), Sunday and Holiday charge is (currently - \$1,250.00), Disinterment (currently - \$950.00), Disinterment/Reinterment (currently - \$1,725.00);

WHEREAS, these increases will be reflected on an updated organizational chart and fee schedule;

BE IT RESOLVED that this resolution will go into effect April 1, 2024.
